Mission statement

The mission of the Cactus and Succulent Plants Specialist Group (CSSG) is to contribute to the conservation of cactus and succulent plants through better understanding of their taxonomy, ecology and threats.

Projected impact 2021–2025

Our projected impact on species conservation status is 1,468 reassessments of cacti and 135 new assessments of other succulents including *Dudleya* and *Pachypodium*.

Targets 2021–2025 ASSESS

T-005 Assess the extinction risk of 67 species of Agave sensu lato (including 35 Manfreda, 17 Polianthes, 14 Agave and one Prochynanthes), seven Hesperaloe and 23 Fourcraea.

T-006 Assess the extinction risk of 46 species of *Dudleya*.

T-007 Re-assess the extinction risk of 1,477 species of Cactaceae.

T-009 Assess the extinction risk of 22 species of *Pachyphytum*.

T-010 Conduct a taxonomic review of Cactaceae.

T-015 Produce a scientific publication on the global assessment of *Agave*.

T-016 Produce a scientific publication on the global assessment of *Yucca*.

Reassess the extinction risk of 1,477 species of Cactaceae: 282

Result description: During this year, we have started working with the reassessment of 45 cactus species in the genus *Copiapoa* and 237 cactus species of the Sonoran Desert.

T-011 (KSR 8)

Number of conservation plans/strategies developed: $\ensuremath{\mathbf{1}}$

Result description: The CSSG, in collaboration with Chester Zoo in the UK, the Conservation Planning Specialist Group, Concepción University in Chile, and the Chilean Ministry of the Environment, has resumed the conservation action plan for the genus *Copiapoa* in Chile that was postponed due to COVID-19. At these early stages of the workshop, the work is centred on defining its organisation and logistics via virtual meetings with the different stakeholders.

Number of threatened species benefiting from in situ conservation action: 844

Result description: Thanks to the efforts of CSSG members Andrea Cattabriga, Pablo Guerrero and Co-Chair Bárbara Goettsch, 844 cacti from the genera *Copiapoa* and *Eriosyce* that were confiscated in Italy were

repatriated to Chile on Monday, 19 April 2021. The shipment of the plants was made possible thanks to the generous support and funding from SSC Internal Grants, B. Willow and Città Studi Botanical Garden of Milan.

Number of SSC members recruited: 2

Result description: We welcomed Dr. Carly Cowel, Senior Science Officer (CITES), Royal Botanical Gardens Kew, UK (Succulents, South Africa, Illegal Trade, UK CITES Scientific Authority – Flora), and Dr. Jared Margulies, Assistant Professor, Department of Geography at The University of Alabama, USA (Illegal Trade), to be part of the CSSG membership.

T-002 (KSR 2)

Number of SSC members recruited: 11

Result description: In 2021, we welcomed 11 new members. Currently, the CSSG has 54 members (with three pending registrations), and we will soon invite other experts from a list that we have been curating over the past year.

Synergy

T-004 (KSR 2)

Enhance collaboration with at least 2 plant Specialist Groups: 1

Result description: The CSSG is commencing the reassessment of the Cactaceae family. For this, the CSSG is teaming up with the Sonoran Desert Plant Specialist Group to start reassessing the approximately 246 cactus species distributed in the Southwest US and Northwest Mexico.

Result description: In 2021, the CSSG successfully transitioned from two newsletters per year to one communication and one newsletter per year. This change in communication products format ensures that our members receive updates and valuable content on the CSSG work in the best possible way. The communications contain information on the progress towards meeting targets, important news, new members and opportunities (such as conferences and funding). The newsletters include opinion

articles related to the conservation of succulents and cacti together with the progress made in achieving the CSSG targets, news and expansion in the membership. In addition, the CSSG sent an invitation to its members to serve in the Editorial Committee to help, along with our chief editor Jafet Nassar, support the communication products of the Specialist Group.
